**ELECTRICAL CODE AMENDMENTS:**

The City of Sugar Land has adopted the 2014 edition of the National Electrical Code with the following amendments:

1. No conductor smaller than No. 12 shall be used in a wiring system.
2. Conductor Material – Conductors shall be of copperclad aluminum, copper or aluminum is sizes 1/0 or larger, unless otherwise stated.
3. The following regulations apply to underground installations:
  - (1) All conductors operating at fifty (50) volts or more shall be installed in conduit.
  - (2) Ridged nonmetallic conduit shall be limited to schedule 40 when below grade and schedule 80 when exposed to physical damage.
