NOTICE

2015 International Fire Code

Occupancy prohibited before approval:

The building or structure shall not be occupied prior to the code official issuing a permit that indicates applicable provisions of this code have been met.

Occupy – To take up space within a building with people, furniture or storage.

Exception – Contract personnel, building material and equipment used in the construction process shall not be considered occupying the building.

Failure to comply may render you and the company you represent liable to penalties provided by law for such violation.

All Commercial Permits will require the following:

- CD or USB: AS-built submittals shall be submitted electronically and include all applicable documents including, but not limited to, permits, use narratives, scope of work, architectural, structural, mechanical, electrical, plumbing, fire, health, civils, Sugar Land design standards, any supporting documents, energy compliance, asbestos reports, third party inspection reports, special inspection reports, manufacture specifications, safety data sheets, etc. in PDF format. This is used to archive drawings and manage compliance of record retention laws. Please do not submit this until the Building Final inspection has been approved, in case any revisions are needed.

Temporary Certificate of Occupancy – may be allowed before completion of the entire work covered by a permit, provided such portion or portions can be occupied safely. A letter by the responsible person is required prior to considering a Temporary CO. The letter shall list work that is not complete, if the request is to stock or open for business and an expected date of completion.
