PLEASE DO NOT ATTEMPT TO SUBMIT PAPERWORK TO FOOD INSPECTOR OR PAY FOR THIS PERMIT UNTIL INSPECTOR HAS CONTACTED EVENT PRODUCER WITH APPROVAL.
