



**NOTICE OF RUNOFF ELECTION**

TO ALL THE DULY QUALIFIED, RESIDENT ELECTORS OF THE CITY OF SUGAR LAND:

NOTICE IS HEREBY GIVEN that a runoff election will be held in the CITY OF SUGAR LAND, TEXAS, on the 7<sup>th</sup> day of June 2025, in accordance with the following ordinance:

**ORDINANCE NO. 2375**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SUGAR LAND, TEXAS, CANVASSING THE RETURNS AND DECLARING THE RESULTS OF A GENERAL ELECTION HELD ON MAY 3, 2025, TO ELECT A MAYOR AND TWO AT-LARGE COUNCIL MEMBERS; CANVASSING THE RETURNS AND DECLARING THE RESULTS OF A SPECIAL ELECTION HELD ON MAY 3, 2025 TO FILL THE UNEXPIRED TERMS FOR SINGLE MEMBER DISTRICTS TWO AND FOUR; AND TO VOTE ON AN AMENDMENT TO THE CITY'S CHARTER; TO CALL FOR A RUN-OFF ELECTION TO BE HELD ON JUNE 7, 2025; AND PROVIDING FOR OTHER MATTERS RELATING TO THE GENERAL AND SPECIAL ELECTION.**

WHEREAS, the City Council called a general and special election to be held on May 3, 2025, to elect a mayor, two at-large council members, to fill the unexpired terms for single member districts two and four, and to consider an amendment to the city charter; and

WHEREAS, notice of the election was required by law and returns of the election have been made by the proper officers and canvassed by the City Council; NOW THEREFORE;

**BE IT ORDAINED BY THE CITY COUNCIL  
OF THE CITY OF SUGAR LAND, TEXAS:**

**Section 1.** That at the elections held on May 3, 2025, the following votes were cast for the following candidates:

**Section 4.** That because none of the following candidates for the office of Mayor, At Large Position One and District Two received a majority vote, the mayor shall certify in writing, for placement on a runoff election ballot for June 7, 2025, the names of the runoff candidates and deliver the certification to the city clerk as required by section 2.027 of the Election Code.

**Section 6.** That the Charter Amendment Proposition A is declared to have not been approved by the voters.

**Section 7.** Runoff Election Precincts, Voting Locations and Voting Hours on Election Day. The voting location for voting on Election Day for each city election precinct shall be as set forth in the Notice of Election published in the Fort Bend Independent no later than May 28, 2025, and incorporate therein Countywide Election Day Centers, or at other such locations as may be designated by the County Elections Administrator. On Election Day the polls shall be open from 7:00 a.m. to 7:00 p.m.

**Section 8.** Runoff Early Voting Locations, Dates and Times. Early voting by personal appearance for all election precincts shall be held at the locations, at the times and on the days as hereafter may be designated by the County Elections Administrator.

The County Elections Administrator, John Oldham, is hereby designated as the Early Voting Clerk. Applications for ballots to be voted by mail can be obtained at:

**Section 9.** Runoff Joint Election. That John Oldham, Elections Administrator of Fort Bend County, Texas, will act as Contracting Officer and will appoint election judges, alternate judges and clerks as described in the Joint Election Agreement and Contract for Election Services between County of Fort Bend, City of Sugar Land, and other Political Subdivisions.

**Section 10.** Appointment of Election Officers. Prior to Election Day, the election judges, alternate judges, clerks and other personnel necessary for conducting the Election will be

appointed by the County Elections Administrator, and the election judges and alternate judges may be changed and the polling places may be combined for some precincts, pursuant to decisions of the County Elections Administrator. The County Elections Administrator shall be responsible for establishing the central counting station for the ballots cast in such election and appointing the personnel necessary for such station. The City Council hereby authorizes the City Clerk to appoint any such other officials not designated herein or appointed by the County Elections Administrator as are necessary and appropriate to conduct the Election in accordance with the Election Code.

**Section 11. Notice of Runoff Election.** Notice of the Election in English and Spanish, must be published at least once between the 30<sup>th</sup> day and the 10<sup>th</sup> day before the election in a newspaper of general circulation within the city territory stating in substance the contents of this Ordinance, shall be (i) posted on the City website no later than the 15<sup>th</sup> day before the election (ii) posted on the bulletin board used by the City Council to post notices of meetings no later than the nineteenth (19<sup>th</sup>) day before the date of the Election; and (iii) posted, not later than the nineteenth (19<sup>th</sup>) day before the date of the Election, in three (3) public places within the City and at City Hall.


**Section 12. Conduct of Runoff Election.** Said Election shall be held in accordance with the Election Code as amended, including Chapter 272 of the Code pertaining to bilingual requirements.

**Section 13. Voting System.** Voting at the election, including early voting, will be by use of the County electronic voting system that has been approved by the Secretary of State.

**Section 14. Canvass.** The official canvass will be conducted by the City Council at a City Council Meeting on June 17, 2025. Under Article II Sec 2.01 (e) of the City Charter, the persons elected shall take the oath of office and begin their duties at the meeting at which the City Council declares the results of the election.

**Section 15. Authority Conducting the Election.** The City of Sugar Land is the authority conducting the called election referenced in this ordinance. The website pertinent to said election is: <https://www.sugarlandtx.gov/148/May-3-2025-General-Election>.
